This is a typewritten copy of the Regimental Book or Journal kept by Colonel James Mills, War of 1812. It was the property of Mrs. E. C. Downing who lived near Mollansburg, Darke County, Ohio. She died this Fall while the Journal was being copied. Her maiden name was Mills, probably a granddaughter or a great granddaughter of Colonel Mills. At all events the Journal has been in the possession of the Mills family since the time it was written. It was never copied until this copy was made.

Colonel Mills' men saw six months service, from February 6 to August 4, 1812. They marched from Hamilton, Ohio by way of Lebanon and Dayton to St. Mary's and then to Ft. Meigs, which is situated at Perryville, Ohio, on the Maumee River then or twelve miles south of the present Toledo and there they were mustered out - mustered out too at a critical time in the campaign.

In a Journal of this kind it must be remembered that it is not a diary of personal experiences. Indeed, it is wholly impersonal. It is a formal record of the movement of troops and more particularly a record of military orders. But, it is not difficult to read between the lines. For example there is the entry of April 4, 1813, when General Harrison and "his suit" arrived at St. Mary's. The General at that time was straining every nerve to get men and supplies forward to Ft. Meigs to meet the anticipated attack of the British. His job was to stir things up and he gave verbal orders to rush forward the boats, etc. He also told the Colonel to stop firing a cannon each morning. Perhaps he objected to the waste of powder in such a way and apparently he saw a good deal of waste and carelessness about the Fort for he directed that the guns be collected and put in the military stores. No such order would have been given had it not been necessary. These Militia Soldiers did things pretty much as they pleased. They did not have the first idea about sanitation for there are many references to cleaning up refuse, burying dead animals and the like. *This is wholly erroneous they may have been advised*

Colonel Mills and his men went on to Ft. Meigs and saw *orders* active service at the front. General Harrison wished to improve *clean* the marksmanship of his men although most of them must have been *well* sure shots, accustomed as they were to hunting from their youth *steps* up. With this in view he ordered that when the guard was relieved he was to unload his gun by shooting at a mark, the prize for the best shot to be a quart of whisky and for the second best a pint. Were these prizes offered today pretty much all America would take up shooting. The winner of the prize unless he shared it wish his comrades, must have been unfit for duty the next day. There was hard drilling at Ft. Meigs to whip the men into shape, two hours in the morning and two hours in the afternoon. But, in spite of this there must have been considerable liberty of action for orders were issued that the men must not go fishing

until after seven o'clock in the morning, nor were they to go fishing without their arms and they were not to go in either direction more than half a mile from the Fort, yet, in spite of all precautions every now and then is an entry of a party outside the Fort by the Indians.

Colonel Mills' Company had not been a month at Ft. Meigs until the British under Procter appeared. General Harrison issued General Orders in the form of a patriotic address. In effect he told his men to look upon the opposite shore, the Battlefield of Fallen Timbers, and to remember Wayne.

On the fifth day of the seige the General issued General Orders congratulating the troops upon their behavior under fire and explaining the causes of Colonel Dudley's defeat. General Harrison must have been consumed with anger over the flagrant disobedience of his orders and torn with grief over the fatal consequences. At all events to his men he spoke his mind in the soldier fashion. Had Colonel Dudley obeyed his orders to the letter he and his men would have been covered with glory. Instead they were destroyed - sacrificed their lives to no purpose. There is in the history of our Wars few more terrible stories than this of these brave Kentuckians marching through the wilderness and on reaching Ft. Meigs they were given the opportunity of rendering distinguished service. They were to land on the west bank of the Maumee, opposite Ft. Meigs, take the battery which was but poorly armed, spike the guns and then immediately before the main body of the British could be rallied they were to return to their boats and cross the river to what might be called the American side. With impetuous gallantry they captured the Battery and then full of unrestrained and unrestrainable courage they pursued the enemy. They broke ranks and went helter-skelter each man for himself and so came on large numbers of Indians and English. Those that were not killed were captured and to add a more horrible chapter to the story many of the captured were massacred by the Indians. No wonder the General said "such is the dreadful effect of disobedience" and on May 9 when the seige was lifted and General Procter, discomfited and discouraged, retired sullenly to Canada, General Harrison expressed his thanks to his officers and men. Colonel Mills was mentioned as having rendered "most important service." But Colonel Dudley's defeat still rankled and the General returned to it with sharper words and more bitterness than before. "It rarely occurs", he said, "that a General has to complain of the excessive ardor of his men, yet such appears always to be the case whenever the Kentucky Militia are engaged. It is indeed the source of all their misfortunes. They appear to think that valor can accomplish everything. x x - such timidity, although not graceful is scarcely less fatal than cowardice."

It is a wonder after such plain speaking that Kentucky could ever forgive General Harrison, but, Kentucky took the rebuke in good part and the State was always strong for the General. The

slaughter of Colonel Dudley's men which followed so fast upon the heels of the massacre on the River Raisin filled Kentucky with grief. There was mourning in hundreds of desolated homes.

During the seige it is evident that the Fort got in pretty bad shape for immediately after the retirement of the British clean-up orders were issued. Probably everyone was tired out after the seige for a week later the field officers of the Ohio Militia petitioned that fatigue duty might be omitted on Sunday. The temporary commandant, General Harrison having gone "to the Settlement", declined the request. In the first place he disapproved of it and in the second place he did not feel competent to rescind any order General Harrison might have made.

There are some odd items as for example an offer of a gill of whisky to every man who found a cannon ball or bomb. The Army was short of these and so the shot fired by the enemy was recovered and used against him. Then there was permission for four men of each company to go into the woods to gather "sallad" - greens of some kind, poke and dandelion perhaps.


On July 21, 1813, the enemy returned to the seige of Ft. Meigs but accomplished nothing. There is a much livelier and better account of this second seige in the Journal than of the first seige.

The by-products of these two unsuccessful attempts to reduce Ft. Meigs was the wearing away of the British forces, beating themselves vainly against rocky walls, or in this case log pickets, and particularly the dissatisfaction of the Indians. They had regarded their British allies as far superior to the Americans, but the repulses at Ft. Meigs and at Ft. Stephenson opened their eyes. They began to see that they had chosen the wrong side and in spite of the influence of Tecumseh they deserted in large numbers. So it was three months later at the Battle of the Thames General Harrison met a force that had already been beaten, that was discouraged and disaffected and that had lost the moral force that leads men to victory.

But Colonel Mills did not participate in the Battle of the Thames. He and his men had enlisted for six months. In August they received their honorable discharge and marched back to their homes in Butler County. Probably they had heard of Commodore Perry's preparations and it is equally probable that all their lives they regretted that their "tour of duty" had been so short and that it had not been their happy fortune to participate in the culmination of the campaign in whose earlier stages they had served with distinction.




The writers of history call such a Journal as this, source material and this particular Journal, which heretofore has never seen the light of day, is particularly valuable in its contemporaneous day to day detail. For example, it would be difficult to find anything more suggestive than the Orders in regard to cleaning up the camps. Such Orders would not have been issued had they not been needed. There must have been fearful laxity in this matter and the constant sicknesses which affected the soldiers came undoubtedly very largely from this very cause.

Then the diet was not what we would call in these days a well balanced ration. It was pretty nearly altogether fish and pork.

Another thing that strikes the modern reader of the Journal is the slowness with which men moved. Of course, there were no roads and the wonder is that they did as well as they did.

It has been a matter of great amazement to me and a Journal of this kind makes it more amazing, that it was possible to keep an Army in the forests in the northern part of Ohio in the year, 1813; swamps and forests marked the landscape - the great black swamp that made up northwestern Ohio was not open bog but an immense wet region, knee-deep in muck and mire during the Spring and early Summer and only passable late in the Fall or when it was frozen. So General Harrison had the double task of conquering Nature and conquering the British and he succeeded in both, greatly adding to his credit.

Hamilton February 6th 1813

This being the time and place appointed by General Orders to rendezvous one company.

Captain John Hamilton appeared and organized his company & commenced drawing Rations &c.

Febry.. 8th This day appointed James Heaton a private in Capt Hamilton's Company Clerk to the Regt agreeably to the laws of the state of Ohio, who took the Oath to support the constitution of the United States and of the State of Ohio and also the oath of Office.

February This day appointed Samuel Bayles a private in Capt Hamilton's company Adjutant to the Regt agreeably to the laws of Ohio, who took the Oath to support the constitution of the United States and also of the State of Ohio, and also the Oath of Office

February 16th This day appointed John M" Closky a private in Capt Hamilton's company Sergeant Major to said Regt who took the Oath to support the constitution of the United States and of the State of Ohio and also the Oath of office.

February 16th the same day last aforesaid appointed John Wells a private in Captain Hamilton's, as Quarter Masters Sergeant to the Regt aforesaid who took the Oath to support the constitution of the United States and of the State of Ohio, and also the oath of Office.

February 17th This day Captain Hamilton Marched from Hamilton to the Crosskeys in Butler county.

February 18th This day Capt Hamilton Marched to Nutts's tavern in Montgomery county.

February 19th This day Capt Hamilton Marched to Dayton crossed Madriver & encamped at Camp Kain, where he was Joined by four companies to wit by Captains Hosbrook, M"Henry, Seton, and Shaw, where also Major Kain appeared and took command

as Major &c

February 21st This day received Orders from the Governor of Ohio through Brigadier General Wingate to March for St. Mary's and there wait for further orders from the commander in chief.

February 23d This day Marched said five companies to Black's, or fallen timber.

February 24th This day Marched to Piqua, and from here sent Surgeon Littell to Cincinnati to procure a supply of Medical Stores &c.

Lorimies Feby 26th 1813

February 25th This day Marched to what is called Perry's Block-house.

February 26th This day Marched, to Fort Lorimies, at which place the Detachment was met by Lieut Col. John B. Campbell of the 19th Regt U. S. Infantry from the Commander in chief, who being authorised wrote and delivered General Orders, of which orders the following is a correct copy.

Lorimies 26th February 1813

Sir, By Order of the commander in chief I am directed to instruct you as to the disposition of the forces under your command. You will therefore please to proceed with all practicable dispatch with the troops under your command to St. Mary's where you will yourself remain, and take command of that post, and all the others on the left line of operations. The five companies at present under your command you will dispose of as speedily as possible in the following manner One will remain at St. Mary's, and One at each of the Forts Amanda, and Woghpochenata and Winchester And One for Forts

Jennings and Brown's (the latter to have a subaltern and twenty men) If another company does not shortly arrive, it may be necessary to send the Rangers to Fort Wayne, which is an important post, and is now weakened by the withdrawal of the Kentucky troops. whose time of service has expired. It is important that the troops intended for the advanced posts should proceed to their places of destination as possible, as the troops now in Garrison are anxious to go home, and ought to be relieved when their period of service expires which is on Sunday next.

You cannot be too impressive in your instructions to the Commandants of the different Forts to be vigilant and prepared for any attack the enemy may make.

Troops and indeed officers too often become insensible of danger, by being habituated to it and frequently expose themselves to annoyance from an Indian Enemy, You will also instruct the officers commanding all the posts particularly those of Amanda and Woghpochenata and the same you will observe yourself at St. Mary's to give every possible assistance to the Quarter Master in preparing Boats & Perogues for the transportation of provision to Rapids. The forces you have are

scarcely sufficient for the defence for the defence of the posts under your command, You will therefore have to dispose of them in the best manner until you are reinforced, which you ought immediately to solicit.

You will receive great assistance from Col. Barbee Commandant at St. Mary's and who you will relieve, whose experience and good Judgment will enable him to give you information that

you will find useful, it therefore will be proper to enquire of him on every subject that may occur to you relative to the service in which you are engaged, It will be essential that you should have two or three more companys, one of which you will send to Fort Wayne, keep one at St. Mary's and send the other to Amanda. and if you had another to dispose of between Forts Jennings and Browns, it would not be amiss. Having had a little experience in Indian Warfare permit me to advise you to be extremely attentive to the duties of the Gard, and compel them to be Vigilant, to ensure which they ought to cry out every Quarter of an hour the time of night and that all is well if they have not discovered an enemy, cleanliness in a Garrison is all important to the preservation of health, it will therefore be proper to detail two or three persons for the express purpose of cleaning the inside of the forts and removing every nuisance, You will also give such instructions & assistance in preserving the public propeity as it may require, You will make Monthly reports to the Com- mander in chief, and direct the Commandants of Garrisons under your command to make the same to you oftener if you think proper of the State of the Forts, and the amount of publick property in each, if this should not be done by the Quartermasters, be always careful and give similar instructions to avoid puting uppon paper anything which if intercepted by the enemy would give them information that might endanger you.

St. Mary's February 28th 1813

This day moved the troops into the Garrison or Fort of St. Mary's and on the same day sent Adjutant S. Bayles, Express to the Governor of the State of Ohio, and to General John Wingate;

The following is a correct copy of the letter express sent to the Governor of the State of Ohio. (to wit)

To his Excellency Return J. Meigs, Governor of Ohio

Last evening we arrived at this place, and this evening all the Kentucky troops will move off. I have only five companies with me, except the company of U. S. Rangers whose time will be out in a very few days, On the 26th Col. John B. Campbell, called on me with instructions from the commander in chief, and my duty is pointed out in writing to attend to, fortify and keep safe this place, Amanda, Woghpochenata, Winchester, Forts Jennings & Browns and Fort Wayne, In three days there will not a man be left at any of the above posts, except a few at Fort Wayne as I am told, There is several Brigades of Packhorses that must go on to Fort Wayne but dare not without Escorts, and at Amanda there is a very considerable store of provisions which must be attended to instantly, I am this Moment detaching One whole company to that place, and several of the others which will leave this place very weak & Therefore Sir I ask for one Battalion of Men, or least three Companies, And that it is very important for them to be here speedily is my real Judgment. For other information I refer your Excellency to Mr S. Bayles my adjutant and express who will be

able to give your excellency further information which I may have perhaps omitted

Same day Ordered Captain Hamilton and part of his company to Woghpoekkennata.

Same day detached from Hamilton's Company Lieut. Shafer and 20 privates to escort 2 Brigades of Packhorses to Fort Wayne, together with a Sergt & 10 men from Capt Shaws Company.

Same day issued an order to Captain Anderson Spencer to March this place with his company of Riflemen,

Same day Ordered that Captain James Manary of the U. S. Rangers, take upon himself the direction of the Spies and the responsibility of giving timely notice of the approach of any Enemy that may be near to or in the neighborhood of this place, and to make daily reports of whatsoever discovered &c

March 2nd 1813

This day ordered that each and every Individual belonging to this Garrison of whatever Rank or station be instructed by the Srgt Major, to have and keep in good order and well charged one stand of Arms and twelve Cartridges ready for use at a moments warning, And the Quarter Master will issue anything necessary for carrying this Order into effect on application of the Srgt Major.

St. Mary's March 8th 1813

Died this day at 12 O'clock William Marshal a private of the pleurisy who belonged to Capt Mc Henry's company of this Regt Whereupon Capt Shaw, Lieut Vance by order examined and took an Inventory of his effects, which consisted of One dollar and twelve and a half cents cash, one pair of Nippers, one whetstone, three awls, one Razor, One Pocket Knife, One lb of tobacco, One spoon, One lined bag, One pair of Woolen socks, One Shirt, two waistcoats, One Lindsey coat, One hunting shirt, One white Roram hat, and One pair of Overalls, which effects aforesaid were put in a bag, to be sent to the family of the deceased,

The same day Ordered that the body of the said William Marshal be interred tomorrow at 12 O'clock in a plain decent manner under the direction of Capt Manary with the honors of War.

St. Mary's March 9th 1813

This day at 12 O'clock the body of William Marshal was Interred in the usual form with the honors of War.

The same day the Colonel visited the troops and post at Woghpoohkenatta, and until his return Ordered that Captain Manary have and exercise the command of this Garrison

St. Mary's March 13th 1813

This day Ordered that the piquets of this Garrison be taken up & moved in and set up so as to reduce the Garrison plat at least one half its present size, and that a proper block house be erected at the North West and South West corners of the same calculated to Rake an enemy from the North, South and West sides of the garrison or Fort, and that the Sergeant Major be charged with the execution of this order &c.

St. Mary's March 16th 1813

The time of the st company of U. S. Rangers having^l expired the Captain thereof having paraded them in the Garrison the Col. reviewed and discharged said company in form, Whereupon the Col. Ordered One Cannon fired as a signal of his respect for the Soldierly conduct of said Company while under his command.

St. Mary's March 21st 1813

This day at 4 Oclock arrived Brigadier General John Wingate, com-
-mander of the left line of opporations, and his Brigade Quarter
Master, who were saluted by the firing of cannon,

The General produced his authority and instructions from Wm H. Harrison Commander in chief of the North Western Army, which read in the following words. (Viz)

"Head Quarters, Franklinton 14th March 1813"

"Sir, The General Order of this day appoints you to the command

"of the forts upon the left line of operations including Fort

 "immense supplies of provisions & other stores which are de
 "-posited in the posts under your command and giving to the
 "Quarter Masters and contractors departments every aid in your
 "power towards forwarding them to the Rappids of Miami. A con
 "-siderable number of boats & perogues have been built, but the
 "quantity is by no means sufficient for the purpose You are
 "therefore to use every exertion in your power to forward the
 "construction of them, As soon as the Auglaize & St. Mary's Rivers
 "are Navigable all the Boats & perogues, that are ready must be
 "loaded & sent off to the Rapids with as strong a Guard as the
 "force you have will possibly Justify, It is presumed however
 "that the danger will not be as great when the river first breaks,
 "as it will be when the season is near advanced, It will be proper
 "however to send Scouts by land a head of the boats to see that
 "there are no body's of Indians waiting their approach.
 "The Detachment at this place is ordered to proceed immediately
 "to St Mary's when they may be disposed of as you may think proper,
 "either in decending the River to the Rapids, or relieving other
 "Troops whom you may think it best to send on that duty.

General Orders

The General cannot pass by the Opportunity which the Event of yesterday presents of expressing to the Troops his

high sense of the distinguished Valor which was manifested in each of the three severe Conflicts in which they were engaged. The attack made by the Indians upon the left flank was repelled by Cannonings. Major Alexander and the Kentucky Militia in the most gallant manner. Colonel Miller and Major. Tod with the Detachment of the 19th Regt. and Craugham and Bradford's Company of the 17th Regt. and Major. Alexander with the Volunteers attacked the enemy's Batteries on the right flank carried them, drove off a superior force of the Enemy and killed and took prisoners the greater part of the two best Companies of regulars in the British service. Before the attack was made on this side the General had ordered one on the enemy's Batteries on the opposite shore by the Kentucky Militia. This was executed by Colonel Dudley at the head of about eight hundred men with great gallantry. The four Batteries were stormed all the Guns but one spiked and every object that the General intended effected. It is truly painful to reflect that this operation so eminently successful in the Commencement should have been brought to an unfavorable issue by the

30

timidity and disobedience of the Troops. The possessing the Batteries and the destroying the Cannon was the sole object of the General in this enterprise. This being done the Troops should have returned to their Boats. This they could have done and all have returned in safety, this however was not done. They remained on the ground confused and disordered, suffered a feint skirmish to draw them into the woods beyond the covering of our Battery where they were surrounded by the enemy, and a greater part of them made prisoners to the British. Such is the dreadful effect of disobedience, and inattention and that fatal Confidence which is

so apt to prevail with Militia upon a first success. Upon the whole the events of yesterday were highly honorable to the American Arms and promises a most successful Termination of the Siege. We have within those lines more than is sufficient to maintain them. A larger number would be in the way. We are provided with every necessary. The General has ascertained that the number of regular Troops with the enemy are really Contemptible. Nine tenths of their force is Indians and Canadian Militia who are the worst in the world. From an almost unparalleled fire from the enemy's Batteries for five days Continuance it is ascertained that they can do us little Injury. Their supplies of provision must be soon exhausted. Nothing then but a little patience and fortitude on our part is necessary, untill the arrival of those

31

large Reinforcements which are coming on, The 24 U. S. Regiment of highly disciplined Troops, And one thousand strong from fort Mapack has been long on their march, and must by this time be on this side of Cincinnati where it will be joined by the remaining Moiety of the Kentucky drafts Colonel Johnson's Regiment of mounted Volunteers one thousand Strong and all the twelve months and other regular Troops which have been recruited in the eighth military District. Upon the whole the Troops may expect to see in a short time an Army of their friends to the amount of at least five thousand Strong. The General will take another opportunity of expressing his sense of the Conduct of those Individuals who distinguished themselves in the late Actions as soon as he is better informed of their respective merits.

General Orders

The Information received by the General and the Movements of the enemy indicates their having abandoned the seige of this post. The General Congratulated his Troops upon having Completely foiled their foes and put a Stop to their Career of Victory which has hitherto attended their Army. He cannot find words to express his sense of the good Conduct of the Troops of every discription, and of every Corpse as well in sustaining and returning the heavy fire of the enemy, as for their Assiduity and patience in the performance of the laborious duties which the Occasion called for. Where merit is so general indeed almost universal it is difficult to discriminate.

The General cannot omit to mention the names of those whose Situation give them an opportunity of being more useful. From the long illness of Capt Gratiott of the Corps of Engineers, Arduous and important duties of fortifying the Camp devolved on Capt. Wood of that Corps, In assigning to him the first palm of merit as far as relates to the transaction within the works the General is convinced that his decision will be acceded to by every individual in the Army, who witnessed his indefatigable exertions, his consummate skill in providing for the Safty of every point. His foiling every Attempt, and his undaunted Bravery in the performance of his duty in the most exposed situation. An unfortunate wound in

33

in the Commencement of the Seige deprived the General after that time of the able services of Majr. Stoddart of the artillery whose zeal and Talents had been eminently useful. Capt. Gratiott in the revision of a severe Illness took Charge of a Battery and managed

with ability and effect. Capt. Cushing of the Artillery and
 Capt. Holt of the 17th Infantry but doing duty with the former
 Corps were extremely active and attentive to their posts. Col.
 Miller and Majr. Todd of the 19th U. S. Infantry, Maj. Ball of
 Dragoons and Alexander of the Volunteers. Col. Mills, Majr
 Redwick and Majr Pitzer of the Ohio Militia, and Maj. Johnson of
 the Kentucky Militia, rendered most important services. To each
 of the above Gentlemen as well as to each Captain Subaltern, Non
 Commissioned Officer and private of their respective Command the
 General gives his Thanks. And expresses his warm approbation also
 of Adj. Bourne Mr Tremble, and Mr. Peters, Conductors of Ordinance,
 Mr. Lyon Principal Artificer, And to sergeant Henderson Jones and
 Meldrum who severally had Charges of Batteries or Block houses.
 The Battery by sergeant Hinderson was as the enemy Confessed
 managed with peculiar efficacy and effect. With respect to Sorties
 which were made on the fifth Instant the subsequent information
 which has been received from the prisoners has given the gallant
 Troops which were employed upon those Occasions, additional Claim
 upon the Gratitude of the General. It is ascertained that in
 both instances the enemy far outnumbered our Troops.

The General gives his Thanks to Brigadier Gen. Clay for the promp-
 -titude with which the Detachment of his Brigade were landed, and
 the assistance given him in forming for the attack on the left. To Col.
 Boswell and Majr. Fletcher for their Gallantry and good Conduct in
 leading them in the Charge made upon the Enemy. To Capt. Dudley,
 Simmons and Madcalf their Subalterns, Non Commissioned Officers and
 privates for the distinguished valour with which they defeated the
 enemy. The General has in the order of the sixth Instant expressed

his sense of the Conduct of the regular Troops and Volunteers which were engaged in the Sorties upon the left flank. But He omitted to mention Capt. Sebrees Company of Kentucky Militia whose Gallantry was not surpassed by that of any of the Companies which fought by their side. The Pittsburg blues led by Lieut McGee sustained the reputation which they had regained equally at Mapasinaway and their gallant associates the Pittsburg Volunteers and Lieut Drum's detachment displayed equal Intrepidity to the Detachments from the Companies of the 17th and 19th Regt. under their Respective Commanders Capt Craugham, Bradford Langham, Eliot, and Neering, the honorable Task was assigned of storming the Brittish Battery defended by two hundred British Grenadier Infantry flanked by a host of Indians and two Companies of Cal Militia. -----

Col. Miller speaks in the highest terms of the Conduct of Lieut. Campbell, Graham, Lee, Curchwal and Reese, and of Ensigns Ship, Hawkins, Emison, Mitchel and Stockden. The General requests Col. Miller, Maj. Todd, and each of the above named Officers together with all the Officers, Non Commissioned Officers and privates who were engaged on the fifth Instant to accept his Thanks.-----The General is under the highest obligation to his Staff as well for their Conduct in the Action of the fifth as for assistance which he received from them throughout Seige. Maj. Hukill Acting Inspector General distinguished himself by his Assiduity, and forwarding the part of our work which was most exposed to the fire of the Enemy. From Maj. Graham Aidecamp his Volunteer Aidecamp John T. Johnsons Esqr. and Lieut. O Fallon Acting Assistant Adj. General as well as from the Dept. Quarter

Master Eubanks he received the greatest assistance. It rarely occurs that a General has to complain of the excessive ardor of his men, yet such appears always to be the Case whenever the Kentucky Militia are engaged. It is indeed the source of all their misfortunes. They appear to think that valour can alone accomplish everything. The General is led to make this remark from the Conduct of Capt. Dudley's Company of the Regt. as he understood that, that, gallant officer was obliged to use his Espontoon against his own men

36

to oblige them to desist from a further pursuit of the Enemy in Compliance with an Order from the General.

Such timidity although not so disgraceful is scarcely less fatal than Cowardice, and in the Instance above had it been persisted in would have given a different result to the Action, as the whole of the Enemy's force were placed near the batteries would have been precipitated on the rear of our Detachment. The pursuit being stopped allowed time for a new disposition under cover of our Cannon, and the enemy's Batteries were attacked and carried without Difficulty. -----

Three Rounds will be fired from the Cannon in the principal Batteries this Day at twelve O'clock in honor of our Brethren who have fallen during the Seige.

The Command of this Garrison having devolved on me when from indisposition I have been wholly unable to discharge even the most ordinary duty, The command of the Garrison and its dependent posts during my indisposition is hereby yielded to Col. Miller. The Commissary will use every possible exertion to secure and preserve in the best manner the whole of the provisions of this Fort. The

acting Quarter Master will take immediate steps to secure and preserve the Boats and Crafts of every description. The Boats left above and below will be collected together. As also all the Bottoms of the flat boats now remaining and left constantly guarded by day. The Quarter master will also cause the general parade Ground to be put in complete order as soon as possible that the Drill of the Troops may Commence. He will also pay great attention to cleansing the Garrison and especially that portion of it not designated to be Cleared by any particular Corps. Too much attention cannot be had by the Quarter Master in Collecting property, distributing and presenting the public property. -----

The General hopes that each particular Corps will vie with each other in the cleanliness of the Ground they respectively Occupy. This kind of pride is easily excited but it must be done by the Vigilance and energy of the Officers. The Officer of the day will make it his indispensable duty to see that the sick and

wounded are properly attended and have every Comfort. No one will leave the Garrison except for necessary purposes and those on Duty, unless by special permission from the Commander in Chief. The first person without the limits prescribed by General Orders for the sporting ground of the Troops without being on duty or having special permission shall be made an Example. Col. Miller will be good enough to take the Command during my indisposition and cause those and such other Orders as he may view proper to be rigidly enforced. I cannot too thoroughly impress upon the Troops that this Garrison its dependent posts and in fact the future successful operations of this Army depend very much on the Vigilance of the present Moment. The indisposition and lameness of the General precludes his general attendance throughout the Garrison, and has compelled additional duties on the field Officers.--

Colo. Mills, Majr. Johnston, and Captain Butler Commandant of the independent Battalion of Volunteers will take the immediate Command of so much of the Encampment as has been already designated and laid out to them.---

Colonel Miller will take the immediate Command of the regular troops from their Junction with Majr. Johnston's Battalion around to block hous No. 2.:--

Colonel Boswell will take the immediate command of the troops from block house No. 2. to block house No. 1.: The disposition of the troops will be as during the former Seige; as to Guard, one third part will be constantly mounted on duty, and when it is practicable one of the Company Officers at least will remain on duty with their men at all hours--

And on discharging every duty the troops will have with them their arms, ammunition &c. and will in no instance fail to lie on their arms at night, except the details already made from the 24th Regt. it will remain as a disposeable force--

The General feels that he will receive every aid and support from the officers, which his ill health may require; he also feels that the Enemy again will be disappointed in their expectation of Conquest. --- We shall shortly receive reinforcements: but have ample force for defence for the present.----- He does not deem

it necessary to appeal to the feelings of the troops composing this Garrison to excite them to deeds of valor on the approaching contest.--

The preservation of the lives of helpless thousands, the honor of the American Country in arms: No other excitement than those are necessary to animate the bosom of all those who now have an opportunity to share the glory of defeating the enemy.---

Verbal orders from my Aid Major Hawkins Major Butler and Major Lowell, and Capt. McCloskey will be respected and obeyed--The men must at all times be found upon the ground they respectively occupy unless absent on duty, and Company officers will most rigidly enforce the observance of this order--The Commandants of Corps will see that their Company officers remain with their respective Commands except when absent on duty--
Strolling about the Garrison when not on business is most positively forbidden--

The principal portion of the 24th Regt. being reserved as a disposeable force will enable Col. Anderson and Lieut. Col. Gains to render to the General great and essential services on every emergency. He solicits their aid with Confidence upon its being yielded with promptness--Fires and lights must be extinguished from sunset untill Sunrise.

This day at night was sent out on express to upper Sandusky and to Lower Sandusky, viz. Mr. Oliver Capt McCune, Thomas McAdams and others.--

Camp Meigs July 22nd 1813

This day at night nearly 12 o'clock an express was sent out to Lower Sandusky viz. Sergt Harrison Sergt McGuire and a frenchman.--

The occasion of the above express was the second seige of this Garrison which commenced on the 21st Inst.

The first attack was made upon the piquet Guard as they were going out to their posts before Sunrise--

The piquet guard which were going to their posts on the lower end of the Garrison were principally killed or taken prisoners, and those which were found, were most horridly and inhumanly mangled--

Camp Meigs July 24th 1813

General Orders

The movements of the enemy indicate an attack of some description--

We have with little loss once repelled the enemy, with a force inferior to our present. No one can doubt but we are more than competent to do it again.--In consequence of an attack, to make the destruction of the enemy more complete the most perfect silence will be observed by the officers, no one will speak or attempt to give orders but those vested with Command.-- To fight is to conquer to abandon our posts is to suffer disgrace, and the most shocking massacre.--

The General cannot believe there is an individual in this Garrison whose breast would not burn with indignation at the idea of the

In the return of the present Detachment of Ohio troops to their families, and homes, it is due to Ohio and her sons to record their honorable Services.---

To Colo. Mills and Major Pitzer his Staff, their Staff, and their respective Commissioned and non commissioned officers and privates, whose term of Service has expired, and to whose promptness in discharge of every duty he has been an eye witness the Commanding General gives his sincere thanks

Camp Meigs July 26th 1813

This day a little before eight O'clock A. M. arrived Capt McCune the express which went out from this Garrison on the night of the 21st Instant bearing despatches from General Harrison to Genl. Clay Commandant of this Garrison.---

About eleven O'clock P. M. Capt McCune left this Garrison again, as an Express.--

After various movements Stratagems Intrigues and Contrivances of the Enemy, the last of which was a sham battle fought among themselves on the 26 Inst and commenced about 4 O'clock P. M. and continuing about three fourths of an hour very hot with small arms in the woods on the great road leading to Sandusky, evidently to induce us out of the Garrison, that they might lead us into a fatal Snare and finding themselves disappointed 109 and all their Schemes abortive,--with Shame and discouragement, they collected all their force together on 28 Inst. about two o'clock and loaded their vessels which consisted, as near as we could ascertain of about one hundred and forty Sail, and as near as we could calculate about five thousand of the British and Indians

we know not how many, but a great host, and now moved off homeward with all possible Speed.--

About three hundred of this host of Indians were well mounted horsemen, attended with a greater number of foot men than perhaps was ever before known to collect in the Western Country and evidently came on with the most determined resolution to conquer and destroy this Garrison.---

Camp Meigs 26th 1813

General Orders

The intelligence just received from the Commander in Chief, is of the most favorable Character.--Large bodies of troops are rapidly collecting, and whenever it is necessary we shall receive reinforcements.--

The Commander in Chief puts great confidence in the troops here, and feels that they are fully able to repulse any force which the enemy may bring against us. Sufficient proofs have been already given that this Confidence is not misplaced, 110 but we should not suffer ourselves to sink into indifference by too much confidence in our own power and security,

The enemy is still around us in large bodies, let everyone continue to be firm and vigilant on his post for a few days more; and the rashness of the enemy may effect their own destruction, and afford another opportunity to the troops here to distinguish themselves by facing the enemy in the field of battle--

The essential Services rendered and the danger encountered by Capt. McCune of the Ohio troops in obtaining this pleasing intelligence entitles him to the gratitude of his Country, and the Commanding

General tenders him his most cordial thanks--

Camp Meigs July 31st 1813

General Orders

The enemy seem to have abandoned the idea of a second Attack on this place for the present.

This recent movement is indeed misterious, that they should assemble a force, equal from all appearance to five thousand in number, and closely infest this post for eight days, without any other millitary movements than a sham fight amongst themselves, cannot well be accounted for.-----

Their present departure may be for some other post, less formidable than this, or but a feint to form their designs by a sudden reappearance and Assault here.---In any point of view we should not see this movement of the enemy with so large a body of troops, with indifference. A few hours of fair wind can bring them from Malden to the piqueting of Fort Meigs. They can do us no material injury except by surprise; guard against that and we have nothing to fear.---

The enemy from the experience of the post must feel that they will find Fort Meigs no easy conquest, and had they had the timidity to assault us the General feels confident, that the troops here would have shared their full portion of honor in the Conquest of Upper Canada.--

Too much cannot be said, in the praise of the persevering Vigilance, both of Officers and of Soldiers of every Corps during the recent of the enemy.--

To designate the particular merits of every individual is at all times a difficult task, and on the present occasion it is not necessary, for the General witnessed an animated zeal in all to discharged their duty.--

If any testimony is wanted in favor of the Soldier like feelings which pervaded the Garrison when the enemy presented themselves, it is to be found in even the wounded and sick, both of Officers and men in throwing aside their Crutches, and abandoning their Cots for posts of danger.---

The General cannot but express his gratefull feelings and thanks to those officers, who in addition to their ordinary duties of personally and all hours and in every difficulty, the General, and from whom he has derived the most essential Services.--

The continuance of that promptitude and vigilance which has already been manifested both by officers and Soldiers, in all that is wanting to repell any force which the enemy can bring against us.--

It is not in the field alone, that the Soldier gathers honor, nor will a grateful Country, fail to reward real merit, whether displayed in the field of battle or found on the nightly watch tower.--

Col Mill with a portion of his Command, as also that of Majr Pitzer--Having honorably served out the Period for which they were called into the Service of their Country; are hereby discharged, and permitted to return to their respective homes--Events within the Control of the present Commander in Chief of this Army, or of our Government, has rendered it necessary, that the Militia of the Western States should compose a considerable portion of the north Western Army--Ohio stands conspicuous for the great zeal, and promptness for which her Citizens have yielded the Comforts of private life for the toils and privations of the Camp.--
